1) Approval of Agenda for 6/18/2024

There was a motion by Barbara Courneya seconded by Lloyd Thyen, to approve the 6/18/2024 PRWA Agenda. All Aye, Motion carried.

2) Approval of Previous Minutes

There was a motion by Barbara Courneya seconded by Lloyd Thyen, to approve the 5/21/2024 PRWA Monthly Board Meeting minutes with a slight change for Conservation. All Aye, Motion carried.

- 3) Committee Reports
 - a. Finance: Balance of \$73,241.53
 - b. Enbridge: nothing new to report.
 - c. NWLT: Barb is no longer doing NWLT. Bob Karls will be with Loon Center events, outreach and education. Purchased 95 acres for aquatic management area for the MN DNR. Workshop on August 15 in Backus at Cass County Land Office at 3pm? for lake associations to share best practices. LSOHC grants become available July 1, 2024, to continue to make lands public and have sustainable forests, about 11,000 acres. Cold water lakes grant and biological grants have been received. 70,000 protected acres used in MN for public use.
- 4) Crosslakers and Loon Center: Hwy 66 and CR 3 project starts July 6 for 14 weeks. Loons and lakes festival June 20-22, 2024. Senator confirmation of loon center to be on their appropriations list for \$1.7M. trips on stewardship have been increasing. Count on loons with Dr. Piper is still active with tagging loons and observations.
- 5) Emily Mining: PolyMet process of mining. Hard to get information to the public.
- **6)** Ag. Efforts: Pasture walk at Brakstad property on June 27, 2024 at 6pm, west of Pine River. Bale grazing impacts and hydroponic greenhouse. Management is important on grasslands. Hunt utilities: hazelnut and agronomics and genetics workshop coming soon.
- 7) Literature Update: envelopes and stationary has been received.
- 8) Discussion of presentation on 1W1P and WRAPS and yearly report with new metrics: Ron and Clay met with Melissa Barrick and Mitch Brinks. Annual PFM report with template. Protected land is public land, includes lakes and forests. Wetlands are protected. Conservation

Easements are protected land. What would metrics look like. Chart shows protected land, and other types of land. Impervious property should be looked at more often. Agriculture and Shoreline buffers discussion and the law/grants. More metrics are needed on farm data but would need farmer participation.
