- 8) Starry Stonewort-WAPOA: PLM company checks 3 x a summer to check for AIS, starry stonewort has been found, it's aggressive. North end of Rush lake to Whitefish. DNR staff dived in the chain of lakes, only found in 1 acre area. Many entities are involved to determine the next steps. DNR divers did a pull of the mass of weeds and carted out, algaecide has been applied.
- **9)** Ag. Efforts: finished up the grazing school, 50 students. Good reviews, very positive. Maybe to host events in the future.
- **10)**Pine River 1W1P: 5-year meeting in Backus recently. Update of the plan is coming soon. More agriculture, total phosphorus. reduction, goals have been exceeded on most goals. The group would like more specifics.
- 11)Back to Basics booth: February 15, 2025.
- **12)**State Amendment: constitutional amendment concerns-increase 5.5% to 7% funding/year. To create grant opportunities for diverse community groups. Allocating lottery funds to



environmental programs, will stay at 5%, ENRTF. Smaller organizations are now able to access these funds the additional 1.5% increase. Wastewater funding is not included in this program.
